Rules Regarding Student Driving and Parking on School Grounds

1. All vehicles driven and parked by students on school grounds must be registered with the school administration. **The cost is \$5.00.** Permits must be visible and valid for the 2021-2022 school year.
2. Students driving to school should not arrive prior to 7:45am.
3. All students must be licensed and covered by insurance.
4. The speed limit in the parking lot is 5 miles per hour. Any form of reckless driving on school grounds is not tolerated.
5. All state and local laws regarding operation of motor vehicles are applicable on school grounds.
6. Students driving to school must park in the student parking lot immediately upon arrival. Special permission must be obtained from the school administration to park elsewhere. Spaces with the letter "F" are for faculty only!
7. Students must enter the school building *immediately* after parking. (sitting in parked cars will not be allowed)
8. Once on school grounds, students may not leave without permission from the school administration.
9. When school is dismissed for the day, students should leave the parking lot within 10 minutes of the last bell. Loitering in the parking lot is not permitted under any circumstance.
10. Failure to comply with the rules and regulations for driving to school and parking on school grounds will result in the suspension of driving privileges for a period of time as deemed necessary by the school administration.

NOTE: Failure to comply with the rules and regulations for driving could result in suspension from school.
