**Scholarship Notification Procedures:**

- All applications must be received, with all four required parts, **Wednesday, April 3, 2024**. It is the student's responsibility to ensure the application package is complete and received on time. Incomplete or late applications will not be considered.
- Scholarship recipients will be notified by **May 17, 2024**. Scholarships will be forwarded directly to the college prior to the start of the **2024-2025** fall semester. This is a one-time scholarship in the amount of \$1,000. The scholarship will expire on **October 31, 2024** and will not be re-issued.
